VII. Unfinished Business

A. Approval of the 2021 Budget & Appropriation Ordinance 20-03

Superintendent of Finance & Personnel Cinquegrani presented the 2021 Combined Budget & Appropriation ordinance that was previously presented and discussed at the November 17, Regular Meeting. The Park Board had a brief discussion with Commissioner Stortz commending the District for being in a positive position despite the ongoing challenges of the pandemic. He commented on the Districts ability to still fund capital improvements, maintain fund balances, and continue to offer outstanding services, programs, and events. Commissioner Bischoff appreciated the additional details specific to financial contingencies should further restrictions and limitations be implemented and that have been presented while Commissioner Weber added that the 2021 budget was well planned and thoughtfully and practically compiled. Commissioner Cornell commended the District on being well prepared through previous efforts and Commissioner Nephew expressed hope that 2021 will be a better year for all. Lastly, Don St. Clair, representing the Citizens' Finance Committee stated that the District has prepared over the years diligently for the unforeseen and unfortunately this was the year it was needed. Following the discussion Commissioner Stortz moved, seconded by Commissioner Weber, to approve Ordinance 20-03 "A combined annual budget and appropriation ordinance for the purposes of the Glen Ellyn Park District for the year beginning January 1, 2021 and ending December 31, 2021."

B. <u>Coronavirus (COVID-19) District Update</u>

Executive Director Harris stated the Governor previously announced that Tier 3 resurgence mitigations would be implemented on November 20th. Since that time further guidelines have been provided and Staff has restructured its current programs and events to conform. Director Harris then provided an overview of the District's programs.

Tier 3 mitigations have had an impact on Health and Fitness centers as group exercise has been modified as well as capacity for the fitness center has been reduced to 25% capacity. Indoor sports and recreation have been paused as well as gatherings for Special Events. He then provided further details of the specific areas.

Currently, the Dance Academy has offered one on one lessons for families as well as some virtual programming for families to participate. Preschool and Kindergarten Enrichment will proceed as scheduled as current enrollment has a maximum of 10 students. All other recreation programs have been either paused, rescheduled or cancelled.

Several Special Events have been cancelled while others have been modified. Donuts with Santa has been modified to an outdoor timed event while Santa on the Stoop has been adjusted to a Day event and has added an additional date to accommodate the waitlist. Polar Express Pajama Party has been cancelled due to the restrictions within the Tier 3 resurgence mitigations but Staff has added a "You've Been Grinched Event" which has no interaction with families, allows all to participate and will provide some seasonal fun for the community.

Harris stated that the Lake Ellyn Boathouse will be closed to all gatherings and will not be open to the public should skating occur at Lake Ellyn. The remote restroom will remain open.

Harris reviewed the various Athletic programs with the Park Board providing that some programs have been suspended and will be reevaluated at a later time. All Star Sports (less Floor Hockey), and Martial Arts have moved to an online format. Harris provided a list of athletic programs that have been cancelled for the remainder of the season and said prorated refunds will be issued to their house accounts. Those programs consisted of All-Star Sports-Floor Hockey, Cyclones Volleyball classes and Thanksgiving camp, Gymnastics, Softball Pitching Clinic, Little Lakers, Winter House Soccer and House Basketball Clinics. Curling clinics have been postponed at this time. Some of the programs that have been modified are Gymnastics which have now offered one-on-one lessons in place of regular classes and Midwest FC Travel Soccer which will continue their training outside through December weather permitting.

Harris provided an update on Ackerman Sports & Fitness Center stating that group fitness continues to offer classes. Classes will be held on the indoor turf with doors open to the outdoors and limited to ten (10) patrons; masks worn always and thus meeting the regulations of the new mitigations. Virtual fitness classes will be offered by staff in December. The fitness center remains open limited to 25 patrons within the cardio area and 25 in the strength area. Open Gym, Open Turf and Pickleball continue with limited numbers and one-on-one training continues within the Center. Ackerman continues to serve the community as they have hosted a week-long food drive in lieu of the annual Glen Ellyn Turkey Trot.

Natural areas continue their ongoing restoration, burns and guided walks for the community abiding by the new mitigations. Trails continue to be open and volunteer workdays are still taking place with a 10-person limit and adhering to the current guidelines.

Harris stated that the Marketing department has shifted focus with the new guidelines promoting the revised programs and creating new programs for the community to enjoy including; Holiday lightmap, cookie decorating contests, and providing ongoing weekly social media tools for its community. The department will continue with its digital only Playbook and has extended the

release of the Winter playbook until December 16th to allow staff time to adjust should further restrictions be implemented.

Other areas that have been adjusted at this time include revised hours for the Spring Avenue and Main Street Recreation Centers, further restrictions implemented for the Paddle Tennis program and adjustments to the Parks department operations to further enhance the safety measures that are currently in place due to COVID-19. These items include a staggered work schedule for Park maintenance personnel, assigned vehicles to staff personnel and minimizing shared use of tools.

Lastly, Director Harris provided an update of the current projects within the District stating that Ackerman Phase IV Improvement project OSLAD grant audit has been completed and submitted to the IDNR for reimbursement. The final meeting with the pool consultant has taken place and the installation of the turf at the Sunset Pool playground will be taking place shortly. Memorial donation projects for 2020 have been completed as well as the Asphalt project at Newton Park. The District continues to work collaboratively with the Village of Glen Ellyn regarding ice skating within the downtown area and staff will meet with Nicor to conduct an energy audit of the District.

The Park Board thanked Director Harris for the thorough update and had a brief discussion of the various programs, guidelines and community events within the District and praised staff for its ongoing efforts to provide recreation and give back to the community.

VIII. New Business

A. Newton Park Asphalt Improvement Payout Request #1

Project Manager Troia stated that this is the first payout from Accu-Paving Co., who is the general contractor for this project. The project consisted of removing and replacing the asphalt surface of the basketball court, the small parking lot to the south and the entry aprons to the northeast parking lot of Newton Park. The asphalt work is complete, and the parking lots and basketball court are open for use. The remaining work, color coating of the basketball court, will be performed in the Spring when temperature and conditions allows.

The Park Board had a brief discussion and following Commissioner Durham moved, seconded by Commissioner Cornell to approve Newton Park Asphalt Improvement Payout Request #1 in the amount of \$45,576.00.

RE: IMET Tolling Agreement

In October 2014, the Illinois Metropolitan Investment Fund (IMET) informed participants of defaults on certain investments within the IMET Convenience Fund (CF). In all, 434 CF accounts from 292 member participants were affected by potentially fraudulent activities by First Farmers Financial, LLC (FFF) totaling \$50,442,142.78. The Glen Ellyn Park District's pro-rated interest amounted to \$288,925.27. In early 2015, on behalf of several member participants, a Tolling Agreement was negotiated between attorneys representing participants and IMET. The primary purpose of the agreement was to preserve all potential claims that may be available to all parties, notwithstanding the passage of time, including applicable statutes of limitation. Counsel's recommendation was that continuing negotiation and cooperation amongst all parties would be more productive than initiating litigation. Thus, on February 17, 2015 the Glen Ellyn Park District board approved a tolling agreement extending the timeline to file a claim to June 30, 2016. Further, on June 7, 2016 the Park District approved an extension to the initial agreement until January 2017 and subsequently additional annual extensions to January 2018, January 2019, January 2020, and January 2021. Copies of the initial agreement and extensions are included.

To date, the Glen Ellyn Park District has recovered \$160,745.51, or approximately 55.6%, of the total amount lost. While some additional dollars have been recovered, there still remains a level of uncertainty regarding future recoveries. It remains the recommendation of park district legal counsel to extend the tolling agreement with IMET an additional four (4) months to May 31, 2021 at which time all parties should have more information on additional disbursements of assets.

This Agreement ("Agreement") is made and entered into as of February 17, 2015, by and between Illinois Metropolitan Investment Fund ("IMET"), on the one hand, and Glen Ellyn Park District ("Participant") on the other hand.

However, neither Participant nor IMET wish to assert the Claims or Defenses at this time, and to defer, on the terms set forth herein, the consideration or pursuit of the Claims and Defenses *inter se*. Therefore, in consideration of the mutual promises stated in this Agreement, Participant and IMET (collectively, the "Parties" and individually a "Party") agree as follows:

- 1. Unless and until this Tolling Agreement is terminated or otherwise terminates pursuant to its terms, none of the Parties shall assert any of the Claims or Defenses against the other.
- 2. The period between the date of this Agreement and the Termination Date, as defined below in paragraph (6), shall not be included in determining the applicability of any statute of limitations, statute of repose, laches defense, rescission right, or any other right or defense based on the passage of time in any action or proceeding, or demand (whether pursuant to a filed complaint or otherwise) brought by or on behalf of Participant against IMET seeking relief based on the Claims and Defenses.
- 3. Nothing in this Agreement shall be deemed to revive any of the Claims and Defenses that are or were already barred on the date of this Agreement. Nothing in this Agreement, or in the circumstances which gave rise to this Agreement, shall be construed as an acknowledgment by any Party that any of the Claims and Defenses has or has not been barred, or is about to be barred, by the statute of limitations, laches or other defense based on the lapse of time.
- 4. Except as expressly provided herein, nothing contained herein shall constitute a waiver of any Claims, demands, causes of action, positions, rights, remedies and/or Defenses, in law and in equity, of any of the Parties. The sole purpose of this Agreement is to implement the tolling described in Paragraph 2 above. Further, nothing in this Agreement will be deemed to (a) create an affirmative obligation on behalf of any Party to take any action to recover any proceeds of the fraud or (b) preclude any Party from seeking, obtaining, or reviewing any other document or communication that it has a right to seek, obtain, or review.
- 5. This Agreement shall not operate as an admission of liability by any Party and IMET specifically denies that it engaged in any wrongdoing or is subject to any liability. Neither this Agreement, nor any action taken pursuant to this Agreement, shall be offered or received in evidence in any action or proceeding as an admission of liability or wrongdoing by any Party.

- 8. This Agreement comprises the entire agreement of the Parties with respect to the tolling of any and all time-related defenses or claims and it supersedes any prior agreements or understanding by or between the Parties concerning those matters. There are no agreements, covenants, conditions, or limitations of this Agreement that are not expressly stated herein. This Agreement may be modified, amended, or supplemented only by a written instrument signed by all of the Parties.
- 9. Each undersigned Party represents, warrants, and states that all legal action necessary for the effectuation and execution of this Agreement has been validly taken and that the individuals whose signatures appear below on behalf of each party are duly authorized to execute this Agreement on behalf of their respective Parties.
- 10. The Parties hereto agree that the mutual promises contained herein constitute good and valuable consideration, receipt of which is acknowledged.
- 11. This Agreement shall be interpreted in accordance with the substantive law of the State of Illinois, without application of choice of law rules. This paragraph shall apply only to disputes arising out of this Tolling Agreement and shall not be construed to modify any choice of law provision or analysis otherwise applicable in any other dispute between the parties to this

Tolling Agreement, and each party reserves the right to assert that other state or federal law may apply to such other potential disputes.

- 12. This Agreement shall take effect as to each Party upon a Party's respective signature to this Agreement as reflected below.
- 13. This Agreement may be executed in counterparts, each of which shall be considered an original and together shall be one and the same Agreement.
- 14. Except as may be required by law, the Parties agree to keep this Agreement confidential and to not to disclose the existence of this Agreement to any third person or make any public comment about the existence of this Agreement. Nothing herein shall preclude the Trustees or staffs of the Parties from discussing and/or approving this Agreement at public meetings or in executive sessions or otherwise in furtherance of their duties. Nothing herein shall preclude IMET from disclosing this tolling agreement to its insurance carrier(s), its accountants or as otherwise may be required by law.
