#### VIII. New Business

## A. <u>Lenox Road Garden Plots Bid Results</u>

Director of Planning and Natural Resources Troia stated that the Village Board of Trustees for Glen Ellyn approved the permit for the Lenox Road Garden Plots. Staff publicly noticed invitations for bids for the Lenox Road Garden Plot project on February 19<sup>th</sup> at which time three (3) sealed bids were received, opened, and read aloud. The bids were competitive and Daybreaker Incorporated, LLC. submitted the lowest lump sum bid of \$350,000. Troia shared that the bid was vetted and found complete. Troia also shared that Daybreaker has been very thorough and attended a scope review of the project and feels comfortable that the project will be completed by the September deadline for the OSLAD grant.

The Park Board inquired about the opening of the garden plots which staff stated would be in summer of 2026. The Board asked various questions about the project including details of the walkway, and the staircase, which staff stated was an alternate and will not be completed at this time due to budget constraints. Commissioner Crickmore also discussed the many nature programs that will have the opportunity to be held at the site in addition to the garden plots. Following the discussion, Commissioner Nephew moved, seconded by Commissioner Crickmore to award the Lenox Road Garden Plots base bid to Day breaker for the amount of \$350,000.

#### B. <u>Ackerman outfield fencing bid results (fields 2 and 3)</u>

Director of Planning and Natural Resources Troia shared that on March 14<sup>th</sup>, staff publicly noticed invitations for bid to install outfield fences at Ackerman Park on Fields 2 and 3. Troia shared that scope of work includes 6-foot-high black fencing with yellow caps that would match other fencing at Ackerman. Previously temporary fencing was used, and this was a budgeted item for \$60,000 including funding from the softball affiliate program. Troia stated that four (4) sealed bids were received and Action Fence, Inc. submitted the lowest lump sum bid of \$35,600. The bid was vetted and found to be complete. Troia shared that Action Fence has installed the majority of the fencing at Ackerman Park as well as other areas within the District.

Following, Commissioner Ward, seconded by Commissioner Nephew, moved to award the Ackerman Outfield Fencing bid to Action Fence for the amount of \$35,600.

# C. <u>District 41 – Facility Use Agreement (Before/After School Program)</u>

Director of Recreation and Facilities Lim shared that the Park District and Glen Ellyn School District 41 has collaborated since 1999 to provide before and after school care to the community. With the construction of the new Kindergarten Center, the Park District will have programming in the new center along with continuing its offering at Churchill School. Forest Glen will partner with the YMCA. Lim provided the revised agreement that reflects these changes and after being reviewed previously by legal counsel, recommends approval of the Facility Use Agreement with School District 41 for the 2025/2026 school year, thus continuing our partnership with Glen Ellyn School District 41.

Following, Commissioner Crickmore moved, seconded by Commissioner Ward, to approve the Facility Use Agreement between the Glen Ellyn Park District and Glen Ellyn School District 41 for the Park District's Before and After School Childcare Program.

#### D. April 2025 Glen Ellyn Park District Board Election Results & Next Steps

Executive Director Thommes congratulated incumbents Julia Nephew, Michael Ward, and Alex Durham on their re-elections to another four-year term with the Glen Ellyn Park District following the April 1, 2025, Consolidated Election. Thommes shared that the fourth position remains vacant as Commissioner Weber will be stepping down as Commissioner and did not pursue running for

re-election. Thommes shared that Park District attorney, Derke Price, was present to discuss the process for filling the vacant seat. Attorney Price shared that a person must fulfill the requirements for the District; legal resident of the District for one year and not be indebted of any notorious crimes. Price shared there was not one way of appointing a person to office, but the Board can discuss candidates within closed session but must vote in open session for election of that appointed person. There is no deadline to replace a vacant opening on a Board and you are able to advertise an open position on your Board once the seat has officially become vacant.

Director Thommes shared that he would like to have one to two Board members along with staff available to conduct interviews with potential candidates following Commissioner Weber's departure from office. The Park Board had a brief discussion on the process and Commissioner Crickmore volunteered her availability to partake in those interviews.

## E. <u>Discussion of Board officers and advisory committee liaisons for May 2025-May 2026</u> Board Secretary and Directors' Assistant Dikker stated that at the May 20<sup>th</sup> Annual Meeting the District will hold their election of Board officers and appointment of Chair/Liaison positions to the advisory committees. Re-elected Commissioners will also be sworn in. In anticipation of that process, consideration and discussion was taken amongst the Park Board regarding interest in serving in those capacities.

Following the discussion, Commissioner Nephew shared interest in serving as Board President, Commissioner Crickmore as Vice-President and Commissioner Ward as Treasurer. President Stortz would like to continue to serve on the Ackerman Sports and Fitness Center Advisory Committee along with Commissioner Crickmore, Commissioners Nephew and Cornell would like to remain on the Citizen's Environmental Advisory Committee and Commissioner Cornell would like to remain on the Glen Ellyn Parks Foundation and serve as a Liaison. Dikker shared that the Park Board of Commissioners could reach out if they have further interest and discussion can also take place at the next meeting as well.

## IX. Unfinished Business

Director of Planning and Natural Resources Troia shared that regular meetings are being scheduled with discussions on the Downtown Park with hopes for request for bids for demolition to go out in October or November in anticipation of breaking ground in early Spring of 2026. The Park Board discussed the upcoming demolition and inquired on timeline, work involved and testing of soils.

The Intergovernmental Redevelopment Agreement (RDA) between the Village of Glen Ellyn ("Village") and the Glen Ellyn Park District ("District") dated March 26, 2025 requires the Village and the District to negotiate a parking license agreement to authorize the Village to use the parking lot at 453 Forest Avenue ("Property") for Downtown Business District parking purposes after the Village transfers ownership of the Property to the District.

The attached Intergovernmental License Agreement authorizes the Village to manage and maintain the Property for Downtown Business District parking purposes, beginning when the Village transfers ownership of the Property to the District per the RDA through the time the District is issued a permit by the Village to commence work at the Property for the District's Downtown Park.

The Agreement allows the Village to continue to offer parking at the Property to downtown business customers as it has previously done in the past for this time period. The number of parking stalls may decrease as the District begins demolition of the existing structures at the Property, and the Village and the District will work together to minimize any disruption for parking lot users due to the District's activities.

**Recommendations:** Park District staff recommends approving the Parking Lot License Agreement for 453 Forest Avenue.

#### INTERGOVERNMENTAL LICENSE AGREEMENT BETWEEN THE VILLAGE OF GLEN ELLYN AND THE GLEN ELLYN PARK DISTRICT FOR DOWNTOWN BUSINESS DISTRICT PARKING AT 453 FOREST AVENUE

THIS INTERGOVERNMENTAL LICENSE AGREEMENT (hereinafter referred to as the "Agreement") is entered into on the \_\_\_\_\_ day of May, 2025 (hereinafter referred to as the "Effective Date") between the Village of Glen Ellyn, an Illinois home rule municipal corporation (hereinafter referred to as the "Village"), and the Glen Ellyn Park District, an Illinois unit of local government (hereinafter referred to as the "District") (collectively, the Village and District are referred to as the "Parties" and, sometimes, individually, as a "Party").

#### RECITALS

WHEREAS, the State of Illinois Constitution ("Constitution"), Article VII, Section 10, and the Intergovernmental Cooperation Act, 5 ILCS 220/1 *et seq.*, provide that the Village and District may contract or otherwise associate among themselves to obtain or share services and to exercise, combine, or transfer any power or function in any manner not prohibited by law or by ordinance, and contract and otherwise associate with individuals, associations, and corporations in any manner not prohibited by law or by ordinance and

WHEREAS, the Village and the District are units of local government under the Intergovernmental Cooperation Act, 5 ILCS 220/2; and

WHEREAS, the District is the owner of the property located at 453 Forest Avenue, Glen Ellyn, Illinois 60137 (hereinafter referred to as the "Property"); and

WHEREAS, prior to the District's ownership of the Property, the Village used the parking lot at the Property (hereinafter referred to as the "Parking Lot") for downtown business district customer parking; and

WHEREAS, the Village and the District agree that there is a continuing need for downtown business district customers to use the Parking Lot or for other parking in the Village's discretion; and

**WHEREAS,** the Village is willing and able to continue to manage, regulate, and enforce parking at the existing Parking Lot pursuant to this Agreement; and

**WHEREAS,** the Village and the District desire to enter into this Agreement to jointly serve the needs of the community in a manner consistent with their history of intergovernmental cooperation pursuant to the Constitution and the Intergovernmental Cooperation Act.

**NOW THEREFORE**, in consideration of the covenants and agreements stated herein, the Village and the District agree as follows:

**Section 1.** Incorporation of Recitals. The foregoing recitals are incorporated into this Agreement as if stated herein.

**Section 2.** Term of Agreement. This Agreement shall commence on the Effective date and expire on the date the Village issues a construction permit to the District for the Property ("Agreement Term") with the understanding that access to the Parking Lot may be disrupted during the District's demolition of the structures located at the Property. During said term, the Parking Lot shall be available to the Village for downtown business district customer parking twenty-four (24) hours a day, seven (7) days a week. All public parking at the Parking Lot will cease on the expiration of this Agreement.

**Section 3. District Grant of License to Village for Parking Lot.** The District grants the Village a license to use the Parking Lot for parking purposes, subject to the following provisions:

- A. <u>Signs</u>. The Village will provide any applicable signs regarding parking at the Parking Lot in its discretion.
- B. <u>Parking Fees</u>. The Village will establish any applicable parking fees and will collect and keep all revenue generated by parking fees.
- C. <u>Parking Requirements</u>. The Village will allow downtown business district customer parking at the Parking Lot subject to the following requirements:
  - 1. <u>Operable Condition/Prohibition of Repairs</u>. Vehicles must be in operable condition and in good repair while parked at the Parking Lot. No vehicle may be repaired, serviced, or covered while a vehicle is parked at the Parking Lot.
  - 2. <u>Short-Term Parking Only</u>. The Village will prohibit long-term storage of vehicles at the Parking Lot. The Parking Lot will be used exclusively for short-term parking of vehicles. The Village will not permit any vehicle to park at the Parking Lot for more than ten (10) consecutive days without being moved out of the Parking Lot.
- E. <u>No Charge</u>. The District will not charge the Village for use of the Parking Lot pursuant to this Agreement.
- F. <u>Restoration</u>. At the end of the Agreement Term or the Extended Term, or whenever the Village discontinues the use of the Parking Lot, the Village will remove all signs and repair any damage to the Parking Lot, normal wear and tear excepted.
- G. <u>Parking Enforcement</u>. The District consents to the Village's Police Department enforcing traffic and parking regulations at the Parking Lot to ensure any applicable Village parking restrictions are enforced, including the provisions of this Agreement.

The District further consents to the Village's Police Department's issuing citations for any vehicle parked without authorization and/or in violation of this Agreement as set forth in Sections 9-2-3 or 9-2-4 of the Glen Ellyn Village Code, as amended.

**Section 4. Removal of Certain Parking Lot Stalls.** The Village acknowledges and agrees that a certain number of parking lot stalls will be removed from the existing Parking Lot when the District demolishes the building located at the Property during the summer months of 2025 while this Agreement is in effect.

**Section 5. Parking Lot Maintenance.** The Village will maintain the Parking Lot in a clean and orderly condition and will provide for the snow removal at the Parking Lot during the term of this Agreement.

**Section 6.** Utilities. The District shall pay for electricity usage at the Parking Lot and shall be responsible for the maintenance of all lighting at the Parking Lot. The Village and the District each make no representations to the other regarding the adequacy and sufficiency of existing lighting at the Parking Lot.

#### Section 7. Indemnification.

Α. **District Indemnification.** The District shall hold harmless, defend and indemnify the Village and the Village's officials, officers, employees, volunteers, and agents against and from any and all claims, demands, damages cause of action, suits, or judgments or liability of any kind, including attorney's fees, cost and expenses, which result or are alleged to result from claims of injury to person or damage to property arising out of any act or omission of the District or the District's officials, officers, employees, volunteers, and agents under this Agreement, including for any condition at the Parking Lot, except to the extent caused in whole or in part by the acts or omissions of the Village or anyone Village is legally responsible for. The Village agrees that, if such a claim is asserted or any such action is brought, then the Village will give immediate notice to the District pursuant to Section 11 below when the claim or action is received by, or action is received by, or first known to, the Village. The Village agrees to cooperate in the investigation and defense of any such claim or action, and that the handling and settlement of any such action shall be performed and concluded by the District. The delivery of written notification will include a copy of all pleadings if a complaint is filed or of all correspondence and exhibits of a claim is filed.

**B.** Village Indemnification. The Village shall hold harmless, defend and indemnify the District and the District's officials, officers, employees, volunteers, and agents against and from any and all claims, demands, damages cause of action, suits, or judgments or liability of any kind, including attorney's fees, cost and expenses, which result or are alleged to result from claims of injury to person or damage to property arising out of any act or omission of the Village or the Village's officials, officers, employees, volunteers, and agents under this Agreement, with regard to the Village's usage of the Parking Lot pursuant to this Agreement. The District agrees that, if

such a claim is asserted or any such action is brought, then the District will give immediate notice to the District pursuant to Section 11 below when the claim or action is received by, or action is received by, or first known to, the District. The District agrees to cooperate in the investigation and defense of any such claim or action, and that the handling and settlement of any such action shall be performed and concluded by the Village. The delivery of written notification will include a copy of all pleadings if a complaint is filed or of all correspondence and exhibits of a claim is filed.

**C. No Waivers of Defenses, Immunity, Rights.** By agreeing to indemnify the other, neither the District nor the Village waives their respective right to assert any defenses or immunities available to them under the Illinois Local Government and Governmental Employees Tort Immunity Act, 745 ILCS 10/1-101 *et seq.*, or any other law. The District and the Village also do not waive their respective rights to limit their liability for injuries to their employees to that provided for in the Illinois Workers' Compensation Act, 820 ILCS 305/1 *et seq.* 

**Section 8.** Termination. Either Party may terminate this Agreement without cause by providing the other Party with written notice at least thirty (30) days prior to the date of termination pursuant to Section 10 below.

Section 9. No Assignment or Rights in Successors; No Third-Party Rights. Neither the Village nor the District will assign any of its rights or benefits under this Agreement to any other entity or person. The rights and benefits under this Agreement are exclusive to the Village and the District and do not inure to any successors of the Village or the District. This Agreement does not confer any rights on any third party.

**Section 10.** Notices. Any notice required to be given by this Agreement shall be deemed sufficient if made in writing and sent by certified mail, return receipt requested, by personal service, or by facsimile or electronic transmission to the persons and addresses indicated below or to such other addresses as either Party hereto shall notify the other Party of in writing pursuant to the provisions of this section:

Mailing of such notice as and when provided above shall be equivalent to personal notice and shall be deemed to have been given at the time of mailing. Either of the Parties may designate in writing from time to time substitute addresses or persons in connection with required notices. Notice by facsimile or electronic transmission shall be effective as of date and time of facsimile or electronic transmission, provided that the notice transmitted shall be sent on business days during business hours (9:00 a.m. to 5:00 p.m. Chicago time). In the event facsimile or electronic notice is transmitted during non-business hours, the effective date and time of notice is the first hour of the first business day after transmission.

**Section 11.** Amendment or Modification. Both Parties acknowledge and agree that they have not relied upon any statements, representations, agreements or warranties, except such as are expressed here, and that no amendment or modification of this Agreement shall be valid or binding unless expressed in writing and executed by the Parties in the same manner as the execution of this Agreement.

**Section 12. Binding Authority.** The individuals executing this Agreement on behalf of the Parties represent that they have the legal power, right, and actual authority to bind their respective Parties to the terms and conditions of this Agreement.

Section 13. Entire Agreement. This document contains the entire agreement between the Parties relating to the rights granted herein and the obligations herein assumed. Any oral representations or modifications concerning this document shall be of no force and effect, and modifications to this Agreement must be in writing and must be signed by all Parties to this Agreement. No right or interest in this Agreement shall be assigned, in whole or in part, by either Party without the prior written consent of the other Party.

**Section 14.** Governing Law and Venue. The laws of the State of Illinois shall apply to the interpretation of this Agreement. Venue for any action taken by either the Village or the District, whether in law or in equity, to enforce the terms of this Agreement shall be in the Circuit Court of DuPage County, Illinois.

**Section 15. Severability.** If any of the provisions of this Agreement shall be deemed illegal, invalid, unconstitutional or unenforceable by any court of law having competent jurisdiction, such decisions shall not invalidate or negate the other remaining provisions of this Agreement.

**Section 16.** Section Headings. The section headings provided in this Agreement are for convenience only and shall not be deemed a part of this Agreement.

Section 17. Waiver. No waiver of any breach of any one or more of the conditions or covenants of this Agreement by the Village or by the District shall be deemed to imply or constitute a waiver of any succeeding or other breach under this Agreement. All the remedies conferred on either the Village or the District in this Agreement and by law shall be deemed cumulative and not exclusive of the other.

**Section 18.** Counterparts; PDF/Email Signatures. This Agreement may be executed in counterparts, each of which shall be considered an original and together shall be one and the same Agreement. A pdf/email copy of this Agreement and any signatures thereon will be considered for all purposes as an original.

**Section 19.** Effective Date. The Effective Date of this Agreement shall be the last date of its execution by one of the Parties as set forth below.

The Village of Glen Ellyn and the Glen Ellyn Park District have partnered to purchase and develop Downtown Park. After extensive input from the public and various boards, a final design has been agreed upon. The final drawings are currently being produced, with the goal of completing construction by the end of 2026.

Once the park is finished, the Park District will operate it as a multi-use event space and open area for the entire Glen Ellyn community to enjoy year-round.

However, not all features are currently funded, including a refrigerated ice rink and a small nature play area within the park. To support these components, the Glen Ellyn Parks Foundation is launching a fundraising campaign to raise \$800,000.

During the upcoming Board meeting, a presentation will be made to inform the Board on the campaign and discuss how they can best support the fundraising efforts.

Ackerman Sports and Fitness Center is heated and cooled by rooftop units. For the 2025 Budget, (4) new units were included for \$233,000. This was part of a replacement schedule. All units are at least 16 years old and have reached their useful life span.

Midwest Mechanical, through the National Cooperative Purchasing Alliance (NCPA) purchasing cooperative was awarded the contract by the Board for this project.

Attached is the first and final payout request for the MSRC HVAC Improvements in the amount of \$190,850. This payout is from Midwest Mechanical.

The work was completed efficiently in April with minimal interruption to building operations and patron experience.

A majority of the units have been replaced recently; only four of the total eighteen units remain to be replaced, which are budgeted for replacement over the next three years.

**Recommendations**: As the services identified within the payout request have been performed, staff recommends Board approval for Midwest Mechanicals payout request in the amount of \$190,850.
