Notice is hereby given that sealed bid proposals will be received by the Park Board of Commissioners of the Glen Ellyn Park District, Glen Ellyn, Illinois, for “Glen Ellyn Park District- Sunset Pool Renovation,” following instructions to bidders and specifications. Bids will be received for the following bid packages:

Demolition, Excavation, Site Utilities, Landscaping, Fencing, Concrete, Masonry, General Trades, Glass & Aluminum, Epoxy Flooring, Painting, Food Service Equipment, Roofing, Waterslides, Swimming Pool Construction, Building Plumbing, HVAC and Electrical.

Bids received after closing time will be returned unopened. The public opening is for information only and should not be considered accepting or rejecting any bid. Award to the successful bidder will be made within sixty (60) days.

A non-mandatory pre-bid meeting is scheduled for **1:00 p. m, Wednesday, May 31, 2023, at Sunset Pool, 483 Fairview Avenue, Glen Ellyn, Illinois 60137,**

The contractor is responsible for all measurements and must personally inspect the site to verify the scope of the work to be bid. The successful bidder must comply with all laws, statutes, regulations, ordinances, rulings, or enactments of any governmental authority which apply to the work or the project. The successful bidder shall pay DuPage County, Illinois, Prevailing Wages as required by the Illinois Prevailing Wage Act (820 ILCS 130) and utilize equal opportunity hiring practices.

Bidders are required to use the proposal form supplied with the bid document supplement. All bids must be enclosed in a sealed envelope and marked on the outside “**SEALED BID: Sunset Pool Renovation.**”
