RE: Financial Assistance Policy

As a community agency whose mission ".....is driven to foster diverse, community-based leisure opportunities, through a harmonious blend of quality recreation programs, facilities and open space which will enhance the quality of life into the future", recognizes that there are community members who are unable to participate in those services due to economic hardships. For those circumstances, a scholarship fund was established years ago to ensure that all residents had access to the District recreational programs, activities, events and facilities regardless of financial ability.

In 2017, the Census bureau found that 6.2% of Glen Ellyn residents live below the poverty line - \$25,465 for a family with two adults and two children. Parks and Recreation are essential parts of life in America bringing community members together by providing places and opportunities where one can increase physical activity, meet with friends and family, reconnect with nature or help a neighbor in need. According to the National Recreation and Parks Association (NRPA), children who live close to and have access to multiple recreation centers were more physically active and less likely to be obese. Couples and families that play together tend to stay together. Family and community ties are improved by spending leisure time with each other.

Recognizing that some residents needed financial support, the Park District established the Financial Assistance Policy in 1995. The Policy was revised in 2002 and reviewed again in 2008. The policy was established to provide a fair and equitable system through which District residents could utilize recreation facilities and programs should they be financially unable to pay for such services. Eligibility guidelines were established which included Glen Ellyn Park District residency restrictions and evidence of need such as Public Aid and School District free lunch program. Financial assistance was limited to \$200 per child per year or \$500 per household per year. In addition to the yearly scholarship allotment, residents are eligible for financial assistance for yearly individual and family pool passes. Another critical component included in the policy is the ability of the Superintendent of Recreation or designee to have the discretionary ability to waive fees and approve financial assistance to residents suffering from short term economic hardship, such as unemployment as well as medical crisis, disability and other extenuating circumstances. The ability to waive fees and extend funding allotment to residents is an important component to the financial assistance process. Many residents who did not qualify under the public aid or school lunch waiver program have benefitted tremendously over the years. Finally, the

Park District recently extended financial assistance to students at Churchill School who do not live within the Glen Ellyn Park District. There is considerable value for children to be able to participate with their classmates in recreational activities such as house league soccer, open swim at Sunset and summer camps.

Since the program was initiated 25 years ago, the annual financial support has risen to an average of over \$30,000. This funding is allocated to only the programs that incur direct expenses as a result of the scholarship participant. Therefore, it does not reflect the complimentary pool passes distributed each summer as Sunset does not incur additional direct expenses because of the complimentary memberships. While the pool passes are the most in demand, other popular programs include swimming lessons, house soccer, the Glenbard West and Glenbard South Summer Sports Camps, the All-Star Sports classes, gymnastics, summer day camps and martial arts. Over 50 different program areas were requested by the scholarship recipients.

While difficult to determine how many residents were turned away due to reaching their financial cap, it is time to increase the recipients yearly financial allotment for several reasons. Program fees have increased gradually since the last review in 2008, however the financial aid allocation of \$200 per individual or \$500 per household has remained stagnant. As a result of the increased fees and stagnant allotment of financial aid, the number of programs a qualified resident can participate in for one year was less in 2019 then 2008. Additionally, the District has initiated efforts to raise funds over the past few years to further supplement the Park District scholarship budget. As a result of efforts this past year, the available funds for 2020 will exceed \$50,000.

Based on increased program fees over the years along with additional available funds through fundraising efforts, staff recommends increasing the financial assistance allotment to \$750 per individual per year while eliminating the family allotment. This not only increases the available funds per person, but also makes the process for the recipients much easier and simpler. Following the first year under the revised financial guidelines, the District can revisit the funding allotment and adjust if needed. Staff would also advise that these guidelines are reviewed every three years as well. Also keep in mind that the Superintendent of Recreation or designee will continue to have the discretionary ability to waive fees and approve financial assistance to residents suffering from short term economic hardship, such as unemployment as well as medical crisis, disability and other extenuating circumstances.

Attached is the current Financial Assistance Policy with changes highlighted in red. Additionally there is comparison information regarding nearby Park Districts and their policies, and the District's outreach efforts over the years.

Recommendation: For the Board to review and provide input. After Board discussion, the policy, if needed, will be revised and presented at the February 18th Board meeting for approval.

Wheaton Park District*

The Wheaton Park District allows \$200 per family member each season for a total of four (4) seasons per year. They also offer 100% funding for pool passes that does not go toward their individual or family allotment.

Carol Stream Park District*

The Carol Stream Park District allows \$250 per individual per year with a cap of \$1,250 per family per year. They do not offer pool passes in addition to their allotment.

*Both agencies do not provide scholarships for trips or contractual programs, while the Glen Ellyn Park District does not put those limitations on our financial assistance.

Outreach Efforts

The Glen Ellyn Park District works in collaboration with Glen Ellyn School District 41, Community Consolidated School District 89 and Glenbard High School District 87 along with local service organizations such as the Glen Ellyn Children's Resource Center, to orient and identify residents that could qualify and utilize Park District services. Additionally, the Park District has made a concentrated effort to further educate and advertise the scholarship program by integrating educational and fundraising opportunities with many existing District events and programs. Also, the District established a few years back, the Friends of Glen Ellyn Parks 501 (c) 3 Foundation. While still in its infancy, one of its main goals is to expand awareness for the need of financial assistance while also raising additional funds to help expand the available scholarships. This past fall, Fall Fete raised nearly \$25,000 for Park District scholarships. Finally, efforts to establish a soccer scholarship program within the Foundation, specifically for those players in financial need participating in Park District youth soccer, travel and house, was created and has raised nearly \$4,000 to date.

GLEN ELLYN PARK DISTRICT POLICY MANUAL CHAPTER IV. RECREATION DEPARTMENT

5.00 Financial Assistance Policy

5.01 Purpose

The Financial Assistance Policy of the Glen Ellyn Park District has been established to provide a fair and equitable system through which District residents may utilize recreation facilities and programs should they be financially unable to pay for such services.

5.02 Eligibility

- A. To be eligible to receive financial assistance the applicant must meet the following criteria:
 - 1. Must be a resident of the Glen Ellyn Park District.
 - 2. Must apply for assistance in written form to the Superintendent of Recreation.
 - 3. Must provide evidence of need such as Public Aid Card, or written recommendation from a recognized Church or School District 41, 87 or 89.
- B. Financial Assistance eligibility will be based upon financial criteria established by State and Federal Guidelines.

5.03 Application for Financial Assistance

- A. Application
 - 1. Applicant shall complete and file the standard application for financial assistance with the Superintendent of Recreation.
 - 2. Applicant shall attach photocopies of evidence of need.

B. Approval

- 1. The Superintendent of Recreation shall approve or disapprove the financial assistance application based upon the application and supporting documentation.
- The Superintendent of Recreation shall notify the applicant by phone or letter of the decision made concerning financial assistance and the procedure which shall be used to pay the amount due.

5.04 Waiver

The Superintendent of Recreation may waive any or all of the eligibility and application requirements as defined by Sections 5.02 and 5.03 above in the case of a direct reference from School District 41, 87 or 89 or from a recognized church. However, at all times, the requirement for residency in the District shall apply.

5.05 Limitations of Financial Assistance

Applicants that qualify for financial assistance shall be subject to the following limitations; including but not limited to:

A. Financial assistance shall be limited to <u>\$750 per individual per year provided that the recreation</u> programs requested have satisfied the minimum requirements. In addition to the yearly scholarship allotment, financial assistance for pool passes will also be awarded to qualified residents.

- B. Registration for the requested recreation programs shall be made through the regular registration procedures.
- C. Applicants must reapply for assistance every twelve months.

5.06 Economic Hardship

As part of the approved 2020 Annual Budget, funds were budgeted for the replacement of the indoor artificial turf at Ackerman Sports and Fitness Center.

The current artificial turf is the original installation from November 2009 and has met its product life expectancy of approximately 10 years. Total costs include all materials, labor, and removal.

Prices are based on The Cooperative Purchasing Network (TCPN), a joint purchase agency that aligns with the Glen Ellyn Park District's Purchasing Policy. Assuring the lowest possible price to the District.

To be environmentally sensitive, and reduce costs, the project will reuse the existing infill and compacted stone base. The old turf will go to a company that recycles it or sells it overseas as used turf.

A few mis-aligned soccer paint markings will be addressed during this project. Overall, our staff is looking forward to the new turf as it is greatly used and appreciated by our patrons. The turf replacement is tentatively scheduled for May 20, 2020 and take approximately 5 days.

Recommendations: Park District staff recommends approving the proposal from FieldTurf for the replacement of the indoor artificial turf through Joint Purchase for the price of **\$131,374.54**. (\$160,000 was budgeted based on preliminary cost estimates)
