IV. Approval Meeting Minutes

V. Unfinished Business

- A. Financial Update Susan Smentek reported the following:
 - Current balance is \$88,777.66 plus \$1,205 deposited on 8/26 via stripe
 - Gator Race gross was \$3,071.91. All but \$3.09 in total fees were covered by donors
 - Gator expenses were \$325.43
 - Ball Family Foundation donation of \$10k will be listed under Halloween Hangout
- B. Scholarship Susan Smenek reported the following:
 - To date in 2024, \$58,089 has been provided as scholarships, 90 families served, 48 recreational programs, 126 athletic programs, 29 pool passes, 8 Ackerman memberships. (\$69,814 value in funding if you count the value of pool passes & Ackerman memberships)

- Stacey reported that everyone who has met the requirements for scholarship funds has received funding.
- C. Improvement
 - Nate Troia reported an update on the Downtown Park Fundraising. All information has been turned into the village who is working to come up with a redevelopment plan. Fundraising goal is still set at \$5 million which is ongoing.

- A. Pop Up Events

- B. Fundraising Events
 - Halloween Hangout October 19 event from 5-9 at the boathouse, there were discussions about livestreaming portions of the event and adding foundation QR code to tables for ease of donating and adding a costume contest entry fee.
 - Susan requested moving ticket sales to give butter platform to reduce fees. Give butter has the capacity for unlimited contacts.
 - We are still soliciting auction items for this event as well as donors and promoting ticket sales.
 - Susan Smentek reported Javi's has been secured as caterer for the event. They require cash payment to provide tax exemptions. There was a discussion as to how the foundation can pay Javi's via cash to maintain tax exemption. Desserts were discussed and Halloween candy was suggested to fit the theme of the evening.
 - Go Green Glen Ellyn is sponsoring the event with eco-friendly glassware.
 - Inspirato refunds have been provided to families from last year's fall fundraiser
 - Santa Photos There are 21 registrations to date and more time slots have been added
 - Giving Tuesday and the end of the year campaign will be on Give Butter.
