Allowable Fees Under FOIA (5ILCS 140/6)

A fee may be charged for the production of public records. Some examples are:

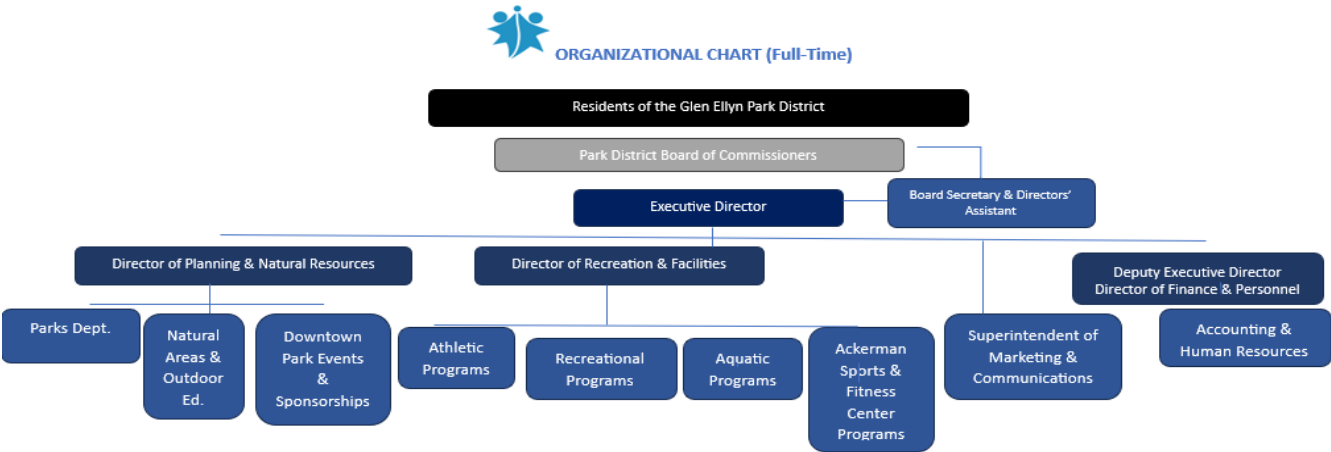
- After the first 50 pages, black and white letter or legal sized copies shall be \$0.08 per page.
- Color copies or copies in size other than letter or legal shall be \$0.10
- Electronic copies requested shall be the actual cost of purchasing the recording medium.
- The cost for certifying a record shall not exceed \$1.00 and can only be performed by the Secretary of the Board and official record keeper for the Glen Ellyn Park District.

PURPOSE:

DISTRICT EMPLOYEES

The Glen Ellyn Park District employs: 37 full-time, and approximately 150 part-time and 275 seasonal employees for a total of approximately 462 employees.

REQUEST FOR PUBLIC RECORDS

1. Each public body shall make available to any person for inspection or copying all public records, except as otherwise provided in Section 7 of this Act. Notwithstanding any other law, a public body may not grant to any person or entity, whether by contract, license, or otherwise, the exclusive right to access and disseminate any public record as defined in the Act (5 ILCS 140/3).
2. Subject to the fee provisions of Section 6 of the FOIA Act, each public body shall promptly provide, to any person who submits a request, a copy of any public record required to be disclosed by subsection (a) of Section 3 and shall certify such copy if so requested.
3. Requests for inspection or copying of public records shall be made in writing and directed to the Glen Ellyn Park District. Written requests may be submitted to a public body via personal delivery, mail, email, telefax, or other means available to the District. The public body may honor oral requests for inspection or copying. A public body may not require that a request be submitted on a standard form or require the requester to specify the purpose for a request, except to determine whether the records are requested for a commercial purpose or whether to grant a request for a fee waiver. All requests for inspection and copying received by a public body shall immediately be forwarded to its FOIA officer or designee.
